INFORMATIONS CONCERNING THE CONSUMER'S RIGHT TO WITHDRAW FROM THE CONTRACT

Right of withdrawal from the contract

You have the right to withdraw from this contract within 14 days without giving any reason.

The withdrawal period is 14 days beginning from the day on which you or a third party named by you but other than the carrier has taken possession of the goods.

You may use the attached model withdrawal form, but it is not obligatory. The consumer must also provide a copy of the invoice.

Effects of cancellation

If you withdraw from this contract, we shall reimburse to you all payments received from you, including the costs of delivery (with the exception of the supplementary costs resulting from your choice of a type of delivery other than the least expensive type of standard delivery offered by us), without undue delay and in any event not later than 14 days from the day on which we are informed about your decision to withdraw from this contract. We will carry out such reimbursement using the same means of payment as you used for the initial transaction, unless you have expressly agreed otherwise; in any

The consumer is liable only for the reduced value of goods for the handling of goods, which is not strictly necessary for determining its nature, characteristics and performance.

Restrictions on the exercise of the right of withdrawal:

Products must be unused, undamaged and in their original packaging. The refund option does not apply to:

- for goods produced according to the exact instructions of the consumer, i.e. goods not manufactured in advance, but on the basis of the consumer's personal choice or decision;
